President Darrell Jett opened the meeting at 7:01 pm.

#### **Roll Call Completed:**

#### **Meeting Minutes:**

• Ken Buckingham made a motion to accept the minutes of the July 10, 2023 meeting. Fran Jett seconded the motion. All were in favor.

## Treasurer's Report:

• Fran Jett made a motion to accept the treasurer's report; it was seconded by Ken Buckingham. All were in favor.

### **Monthly Bills**:

• Fran Jett made a motion to pay the bills; it was seconded by Gary Long. All were in favor.

#### **Clerk/Treasurer Questions:**

Gary Long asked Clerk/Treasurer Reynolds about her recent workshop in Bloomington. Sheryl discussed the legalities of destroying records and the new law regarding renewal of liquor licenses.



#### **Trustee Concerns:**

• John Dankoski reported about his efforts to contact a fire department volunteer regarding fire extinguishers and smoke alarms.

#### **Water/Sewer Concerns:**

- Virginia Kenny asked why Donnellson is still on a boil order. President Jett explained the low chlorine issues. Sheryl Reynolds expanded on the issues.
- John Dankoski expressed concern about low meter holes and who is responsible if someone injures themselves. President Jett stated that the property owner is responsible.
- Clerk/Treasurer Reynolds gave an update on the Lead Service Line Inventory project. It is no longer being conducted by 120 Water via EJ Water.

- Gary Long made a motion to bypass the purchase of a CD this month. It was seconded by Ken Buckingham, all were in favor.
