ORDINANCE NO. 2023- 04

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF
TAXES FOR THE VILLAGE OF DONNELLSON, ILLINOIS
FOR THE FISCAL YEAR BEGINNING MAY 1, 2023
AND ENDING APRIL 30, 2024

WHEREAS, the President and Board of Trustees of the Village of Donnellson have heretofore considered and adopted Ordinance No. 2023- 04, said ordinance being “An Ordinance Adopting a Budget and Appropriation for the Village of Donnellson for the Fiscal Year Beginning May 1, 2023 and Ending April 30, 2024”; and,

WHEREAS, the President and Board of Trustees have further heretofore considered and adopted Resolution No. 2023- 04 being “A Resolution Determining the Estimated Revenues to be Raised by Taxation for the Fiscal Year Beginning May 1, 2023 and Ending April 30, 2024, and Determining the Necessity of Truth in Taxation Notice and Hearing,” in which it was determined a Truth in Taxation Notice or hearing in accordance with the provisions of the Truth in Taxation Act were not required prior to adoption of the levy ordinance; and

WHEREAS, the President and Board of Trustees finds that for the fiscal year concerned it is necessary that taxes be assessed and levied as is hereinafter more specifically set forth.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF DONNELLSON, ILLINOIS:

Section 1: That the total amount of appropriations for all corporate purposes legally made and to be collected from the tax levy for the fiscal year beginning May 1, 2023 and ending April 30, 2024, is hereby ascertained to be Sixteen Thousand Three Hundred Eighty and 00/100 Dollars (\$16,380.00).

Section 2: That the sum of Seventeen Thousand One Hundred Thirty and 00/100 Dollars (\$17,130.00) is hereby levied upon all the taxable property within the Village of Donnellson, Bond County and Montgomery County, Illinois, as prorated between such counties, subject to taxation for the current fiscal year for the purposes of the Village’s General Fund, Audit

Fund, Police Protection Fund, Insurance Fund, and Social Security/Medicare Fund, and the amounts to be levied and collected by taxation being as follows:

General Fund (Corporate)	\$ 2,740.00
Police Protection	\$ 720.00
Audit	\$ 4,690.00
Tort and Insurance	\$ 7,440.00
Social Security/Medicare	<u>\$1,540.00</u>
Total	\$17,130.00

Section 3. That the total sum of Seventeen Thousand One Hundred Thirty and 00/100 Dollars (\$17,130.00) ascertained as set forth above, shall be and the same is hereby levied and assessed upon all property subject to taxation within the Village of Donnellson, Bond County and Montgomery County, Illinois, according to the value of said property assessed and equalized for state and county purposes within the fiscal year concerned.

Section 4. That there is hereby certified to the County Clerks of Bond County and Montgomery County, Illinois, the sums set forth above which are required to be raised by taxation.


Section 5. That the Village Clerk be authorized and is hereby directed to duly certify a copy of this ordinance (and file such other certified copies of this ordinance as may be necessary or required) with the County Clerk of Bond County, Illinois and County Clerk of Montgomery County, Illinois, on or before the time required by law.

Section 6. That this Tax Levy Ordinance be and hereby is adopted in accordance with and pursuant to the provisions of the Illinois Municipal Code and shall be published in book or pamphlet form upon its passage and approval, whereupon, this ordinance shall be effective as provided by law.


